**NOTICE**

**Regd- Implementation of Economically Weaker Section (EWS) seats**

As per UGC's Letter No. F.NO. 81-1/2019 (CU) dated 18<sup>th</sup> January 2019, CIT Kokrajhar shall implement the Economically Weaker Section scheme from the academic year 2019-20.

10% of the total seats shall be reserved for member of EWS category satisfying the criteria mentioned in O.M. No. F. No. 12-4/2019-U1 issued by DoHE, Ministry of Human Resource Development read with O.M.F. NO. 200013/01/2018-BC-II issued by Ministry of Social Justice and Empowerment, Govt. of India.

Accordingly, candidates who are not covered under the scheme of reservation for SCs, STs and OBCs and whose Family has gross annual income below Rs 8.00 lakh (Rupees eight lakh only) are identified as EWSs for benefit of reservation. Family's income shall also include income from all sources, i.e. salary, agriculture, business, profession, etc., for the financial year prior to the year of application. Also candidate whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the Family's income:-

- i. 5 acres of agricultural land and above;
- ii. Residential at of 1000 sq ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential, plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

**INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:**

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given below shall only be accepted as proof of candidate's claim as belonging to EWS: -

- (i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tehsildar and
- (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
